# Investment Schedule

Recommended Investment Schedule is 100% voluntary. It was established and approved by the Board of Directors as a guide to determine a member's Equitable Investment based on willingness and ability to invest in Claremore's business future.

## Standard Investment Schedule

1 – 5 employees.....	\$210.00
6 – 12 employees.....	\$275.00
13 – 20 employees.....	\$400.00
21 – 30 employees.....	\$550.00
31 – 50 employees.....	\$710.00
51 – 100 employees.....	\$946.00
101 – 200 employees.....	\$1,265.00
201 and over employees.....	\$1,580.00 plus \$2.00 per employee over 201

**BASE UNIT** = \$200.00 – Any member paying a base unit will be considered a VOTING MEMBER. Any member paying under the base unit will be considered a NON-VOTING MEMBER. *One employee equals a 35-hour work week employee. Part-time employees should be pro-rated accordingly.* Statements are mailed out 60 – 90 days in advance of due date, which is the first day of member's anniversary month. All members not having paid the required amount by the due date will be given a 30-day grace period before Chamber membership services and benefits are cancelled.

A company/member shall be entitled to one (1) representative for the base membership of \$200.00. Each additional \$200.00 in investment, above the base unit, shall authorize an additional representative from that company or organization.

The employee of a member who wishes to be an active representative of a company when their investment rate does not warrant additional representation may join the Chamber at a *Membership Associate Rate* of \$80.00 and will receive full membership services.

**BUSINESS CONCERNS:** Retail and wholesale trade and services, amusements, auto dealers (new/used), service stations, garages, printers, laundries, cleaners, transportation, real estate, insurance, restaurants, manufacturers, processors, distributors, construction firms, and sellers of goods and services not otherwise classified will be based on the *Standard Investment Schedule* above.

**PROFESSIONALS:** Attorneys, physicians, architects, accountants, professional engineers, veterinarians, and such other professions as the Directors may define from time to time will be charged \$200.00 per professional.

### **MOTELS, HOTELS, APARTMENTS, BED & BREAKFASTS:**

- A. Motels and hotels pay \$200.00 for the first twenty (20) units; \$2.00 for each additional unit; \$200 additional for a restaurant attached as part of the business.
- B. Apartments pay \$200.00 for the first twenty (20) units; \$2.00 for each additional unit.

**MOBILE HOME/TRAILER PARKS:** First twenty (20) spaces cost \$200.00; \$2.00 for each additional space.

### **NON-VOTING INDIVIDUALS/RETIREES/CHURCHES/CLUBS & ORGANIZATIONS ASSOCIATE INVESTMENTS:**

- A. **Individuals:** \$110.00 for individuals not employed or on individual contractual agreement with a Chamber member or employed/on contract to a potential Chamber member. This category includes an individual employed in/elected to public service government positions.
- B. **Retirees:** \$80.00 includes persons retired from active business practice and enterprise and who are in no way employed in a gainful occupation.
- C. **Churches, Civic Clubs, & Organizations:** \$80.00 per year regardless of the number of members.

No person shall be eligible for membership through this category if they qualify in any other category. No individual/club or organization representative in this category will be allowed a voting status unless a base unit of \$200.00 is paid.
